A GUIDE TO RIVERLAND ENERGY COOPERATIVE'S DIRECTOR NOMINATION PROCESS

Cooperative, we prioritize
democratic principles that
empower our members to actively

participate in shaping the organization. Each member holds one vote, regardless of their investment or electric usage, ensuring equal representation and opportunity. To enhance transparency and engagement, we aim to educate our members about the process of becoming a director and the critical role they play in this democratic structure.

District Committee Nominations: *How It Works*

In December, members in Districts 3, 4, and 8 will receive a letter listing all members within their subdistrict. They will elect representatives to participate in a District Committee Meeting held in February. If elected as a district committeeperson, individuals will serve a four-year term, which includes attending one meeting annually in February. Additionally, members in all other districts will receive a notice about their district committee meeting in January. The role of district committeepersons is pivotal. These individuals attend detailed presentations from the Cooperative's management team, review proposed bylaw changes, and nominate candidates for the board of directors.

The February district committee meeting prepares for the **Annual Meeting on March 28**, where names are placed on ballots for director positions. This year, members in Districts 2, 5, and 9 will be eligible to nominate candidates for the upcoming board of director terms.

If you're interested in representing your district, please contact Emily Dregney, HR/Admin Assistant, for further details. This is your opportunity to make a direct impact within your community and contribute to the cooperative's governance.

Board of Director Nominations: What You Need to Know

At the district committee meeting, members in Districts 2, 5, and 9 will nominate candidates for election to the board of directors. Candidates must reside in the district they wish to represent. If two nominations occur, these names will be added to a district-specific ballot for voting prior to and during the upcoming Annual Meeting.

Additionally, members can run for the board of directors by petition. Petitions require at least 10 signatures from members within the district and must be filed with the Cooperative's office within 7 days after the District Committee Meeting.

The current directors eligible for re-election include Bryce Lisowski (District 2), and Bernadine Zingsheim (District 9). Director Dan Filla (District 5) will reach his term limit and cannot seek re-election this year. Members of Districts 2, 5, and 9 interested in being nominated are encouraged to review the qualifications for directors and contact Emily Dregney for guidance.

To provide insight and answer questions, Riverland Energy Cooperative is hosting an **informational meeting** for all members interested in becoming directors. Regardless of your district, join us on Wednesday, January 21, at 5 p.m. either at our Arcadia Office or virtually. If you are interested in attending virtually, please contact Emily Dregney or Jordan Tamke by 12 p.m. on Tuesday, January 20, so they can get your information to send you the link to join the meeting. This meeting will cover the responsibilities, qualifications, and steps involved in becoming a director. (4C23A0003) Whether you're uncertain about the process or ready to get involved, the cooperative is here to support you.

By getting involved, whether as a district committeeperson or a director, you contribute to the success and sustainable

Director Qualifications:

- Must be willing to abide by and uphold all Articles, Bylaws and Policies of the cooperative to the best of your ability.
- Must be bondable.
- Must agree to disclose any potential conflicts of interest and abstain from voting on any issue, which may be construed as a conflict of interest.
- · Cannot be employed or have financial interest in a competing enterprise.
- Cannot gain substantial revenue from the sale of goods or services to the Cooperative.
- Must disclose if closely related to an employee of the Cooperative.
- Must sign an application for serving on the board of directors

 Cooperative Association.
- I will agree to prepare for, attend, and participate in regular and special board meetings and board committee meetings.

- I will agree to be responsible for helping to set policy, but will not be involved with day-today operations of the cooperative.
- I will be dedicated to the well- being of the Cooperative, and the "Seven Cooperative Principles".

Cooperative Principle #2: Democratic Member Control:



Elected representatives (directors/trustees) are elected from among the membership and are accountable to the membership. In primary cooperatives, members have equal voting rights (one member, one vote); cooperatives at other levels are organized in a democratic manner.



Rechargeable Batteries


