*I understand that I may be asked to contribute to the cost of construction as per Policy #9, which I have read, and signed.*

*I will execute an easement on the property, become a member of the Cooperative, and pay all required fees and deposits. I will comply with all requirements to provide the necessary facilities for connection to the Cooperative's facilities. I accept the responsibility for all costs incurred to move, relocate, or change the electrical facilities from their initial installation site as per my request, action or approval.*

*If I am not the owner of the property, I will assume the responsibility for notification and approval of the owner.*
