

APPLIANCES & APPLIANCE RECYCLING 2022 Energy Efficiency Incentive Form

ELIGIBILITY CRITERIA

- > New appliance must be on cooperative's lines. Recycled appliance must have been removed from service on cooperative's lines.
- » New and recycled appliances must be electric.
- Incentive not to exceed the appliance cost. Appliance recycling qualifies for the entire incentive, regardless of the recycling cost.
- Incentives are in place through December 31, 2022. Funds are limited so submit required documentation as soon as possible.
- Required documentation must be submitted within 3 months of purchase or recycle date.
 Additional eligibility criteria may apply. Program is subject to change or cancellation without notice. Contact cooperative for details.
- Required documentation listed below must be submitted no later than 3 months after purchase or recycle date.
 - » This incentive form
 - » A copy of your receipt or invoice for each item with purchase price(s) circled ENERGY STAR label for each item, if applicable
 - » For recycled appliances, include documentation showing appliance was in working order prior to recycling
