### **Billing Statements to Include a Monthly Demand Line Item**

You will soon see a line item on your electric bill called "demand charge."

Demand charge is based on each member's maximum "demand" put on the cooperative's distribution system. The amount of electricity you consume in a



month is measured in kilowatt hours (KWH), while "demand" is measured in kilowatts (kW). The max demand is the highest energy used in a 15 minute period over a month. That means the 15 minute interval that your business or residence is consuming (or "demanding") the most electricity, in a given month, establishes your demand for the month. The demand charge line item will have a date and time stamp of when it occurred for your service, with a zero charge.

Demand is a key component in Riverland's wholesale power costs. The ability for the membership to recognize what demand is and how it can be reduced will help Riverland control wholesale power costs. It is important to understand that demand isn't necessarily about *how much* energy you use, but *how and when* you use it over the course of a month. For instance, a typical residence can control demand by turning off the air conditioner while doing laundry. By not allowing the A/C to run at the same time as the electric water heater and/or electric dryer you are reducing your demand.

You should see this added to your statements in February or March. If you have any questions, feel free to call and ask for our Energy Services department.

## **2023 REBATES**

Riverland Energy continues to offer several types of rebates for residential, agriculture, and business accounts, including custom options. ### The Co-op's Challenge

Today our world faces a volatile and uncertain future. Changes on so many different fronts have created challenges for the Cooperative. Inflation is hitting the Cooperatives just like it is hitting you.



Over the last few years, we kept our rates level, even as costs of supplies escalated. The pressure on our rates has been increasing this year as costs of power are rising. Dairyland Power Cooperative, our power supplier, is informing us about the potential for higher costs of generation. Power cost is more than half of all our expenses (60%), so an increase in this area can be impactful.

Over the last 18 months, we have seen material prices rise quickly along with their corresponding delivery lead times. This has caused us to change the way we source materials. As an electric utility, we must maintain inventories to allow us not only to do our daily line construction and maintenance, but to be prepared to respond to storms and potential disasters where material can be wiped out in a couple of days. And like everyone else, fuel costs have affected us too, and we are incurring higher diesel and gasoline cost to run our trucks and some of our equipment.

We have not changed our rates in three years, and while the Cooperative is strong financially, we have to keep up with the market forces that are impacting us. Members can expect a rate change this year, but we do not have the final numbers in place yet. We are still working on a new rate schedule, and any rate change will likely take effect in May 2023.

We will make every effort to ensure that we limit any increase to you, while ensuring the Cooperative operates as efficiently as possible and maintains a sound financial position.

## 2023 Scholarships

#### **Traditional and At-Large Scholarships**

#### Line Worker Scholarships

Two \$1,000 Line Worker Scholarship will be awarded to individuals pursuing a post-secondary education in an electrical line worker program. The applicant must be a senior in high school.

### Energy Efficiency Tip of the Month

Insulating your electric water heater can reduce standby heat loss by 25% to 45%, saving you 7% to 16% on annual water heating costs.

The Dept. of Energy rates this project as medium difficulty, meaning most homeowners can tackle this project on their own. You can purchase pre-cut jackets or blankets for about \$20 at most home improvement stores. Visit energy.gov for project tips and additional considerations.

# Carbon dioxide safety

Often called the "silent killer" because of its odorless, tasteless, and colorless nature, carbon monoxide remains the leading cause of accidental poisonings in the United States, according to the Centers for Disease Control and Prevention.

To prevent carbon monoxide poisoning in your home, following these tips:

- Have your fuel-burning appliances inspected by a trained professional at the beginning of every heating season.
- Make certain that flues and chimneys are connected, in good condition, and not blocked.
- Never use a charcoal grill indoors or charcoal briquettes in a fireplace.
- Do not sleep in any room with an unvented gas or kerosene space heater.
- Do not use any gasoline-powered engines (mowers, weed trimmers, snow blowers, chainsaws, small engines, or generators) in enclosed spaces.

• Install a batteryoperated carbon monoxide detector in your home and check or replace the battery twice a year.



# **Generate Safely.**

Never use a portable generator indoors.

Do not plug generators into standard electrical outlets.

Use heavy-duty extension cords to connect appliances into the generator.

Start the generator before connecting appliances.
