Eligibility and Guidelines:

Students from the following schools are NOT eligible for at-large scholarships: Alma, Arcadia, Blair-Taylor, C-FC, Durand, Eleva-Strum Central, Gale-Ettrick-Trempealeau, Gilmanton, Holmen, Independence, Mondovi, Onalaska, Osseo-Fairchild, and Whitehall.

One of the applicant's parents or legal guardians must be an active member and a bona fide resident of Riverland Energy Cooperative. A billing number must be provided in their name. Children of full-time REC employees or directors are eligible.

An applicant whose parent or legal guardian is not an active member, but resides in Riverland Energy service territory and is responsible for the electric bill, may be eligible. The applicant must have the active member send a letter that states that the applicant's parent or legal guardian is reimbursing the active member for the electric bill at the residence. Upon receipt of the letter, the application will be considered eligible for the scholarship drawing.

The recipients will be chosen in a random drawing via Facebook Live on Friday, March 5, 2021 at 12:00 p.m. Recipients do not have to be present to win.

Payment will be made upon completion of the first quarter or semester of college, vocational, or technical school.
